 - A. For the semen shipment, the collection fee is \$250 in addition to the booking fee, and the cost of shipping (approximately \$150) and a container rental fee of \$100 will be in addition to the booking fee.
 - B. All subsequent shipments of semen will be billed at \$250 (for the Collection paid to the Stallion Owner) plus the cost of shipping paid to the Veterinary Hospital by Mare Owner. Please list an email address and a PayPal invoice will be sent to cover the cost of any and all shipments needed. These charges are the full responsibility of the Mare Owner. NO SEMEN WILL BE SHIPPED WITHOUT FIRST PAYMENT. All future shipments will be billed and are payable BEFORE SHIPMENT.
- 3. <u>Breeding Agreement:</u> The Stallion Owner shall collect, prepare for shipment & ship frozen semen to Mare Owner at designated address specified by Mare Owner. If this shipment results in the birth of two foals an additional Stallion Service fee of \$1000 for purebreds, and \$750 for other breeds will be due within 30 days of foaling for registration of the foal.
- 5. <u>Health Suggestions for Semen Transport:</u> Internal examination and negative uterine culture by a licensed veterinarian is highly recommended for the health and safety of the mare and foal within thirty days prior to first breeding. The results of this exam are to be received by agent prior to first shipment of semen. If the Mare Owner does not provide proof of this exam, the stallion owner may choose to continue to provide semen for the cost of collection and shipping until the end of the breeding season, but if the mare or substitute

The MARE OWNER shall assume all responsibility for the condition of the MARE, and shall bare all risk of loss or damage to the MARE, by whatever means, and therefore agrees to hold the STALLION OWNER, or any person(s) employed by or associated with the STALLION OWNER, harmless for any or all damages associated therewith.

Addendum 1: RETURN PRIVILEGES/LIVE FOAL GUARANTEE

- 1) It is suggested that the mare be examined by a licensed veterinarian at or before 30 days after last date bred, and Agent must be notified of her breeding status after each examination or all guarantees are null and void.
- 2) Should mare abort, absorb the fetus or fail to conceive, return privileges are guaranteed in the current season (March 15 August 30). The Mare Owner has the option to:
 - a) Re-breed the same mare as stated in the contract or
 - b) Substitute mare upon approval of Stallion Owner.
- 3) At the end of the current season there is no live foal produced, the Mare Owner shall have the option of rebooking in the following season with no additional booking fee, but contract is only valid for two full breeding seasons. If the said mare does not settle within the two breeding seasons this contract becomes null and void and all money paid is forfeited.
- 4) Should the mare fail to produce a live foal (defined as one that stands and nurses), return privileges are guaranteed for the following season. Rebooking in the following season will require the collection fee of \$250 and shipping fee for each additional semen shipment.
- 5) This guarantee does not apply unless the following requirements are met:
 - a) Breeder is notified by registered or certified mail, return receipt requested, within 48 hours of delivery of the aborting or the foal's death
 - b) A statement by a licensed veterinarian follows within 10 days of setting forth details Thereof and certifying that such abortion or death did not result from any act or omission of Mare Owner and that all due care had been exercised and that the mare had been afforded all reasonable protection.
